Senior Match Play

There will be as senior (50+) match play championship if there are enough entries. This will be its own match play flight and the participants will not be eligible to compete in the open match play divisions. The senior match play division will have a maximum of 16 players seeded from the stroke play qualifying and all players in the senior match play will from play the white tees on both courses (also no 36-hole days for seniors). If there is not enough interest in the senior match play division, players will be given the option to compete in the open match play divisions or receive a refund for the match play portion of the tournament. Players must decide to enter into the senior match play prior to the first round of stroke play qualifying.
